Volunteer work included supporting Immaculate Heart of Mary Parish, Stewardship Center/Food Bank, as well as numerous fundraising projects ,as well as Denver Metro community projects.

Supporting IHM Parish include supporting our Clergy , the Denver Archdiocese and The Denver Seminary .
