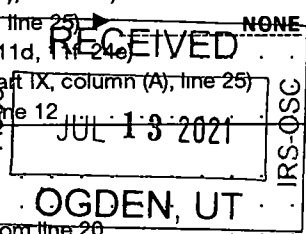

**This class-room afloat seminar is based in Mexico aboard the 1924 M/V Westward, which is owned by the U.S. based company Pacific Catalyst. The voyage re-explores the historic expedition of marine biologist Dr. Ed Ricketts and novelist John Steinbeck in Baja/Gulf of California (otherwise known as the Sea of Cortez), which is a UNESCO World Heritage Site known for its extraordinary biodiversity. We focus on both the natural and human history of the Baja region as well as on the current environmental impacts and conservation challenges related to climate change and human dependence on marine resources.**

Traveling roundtrip from Juneau, Alaska, this voyage focuses on the glacial and natural history of Glacier Bay National Park with a mix of exploring by sea kayak and hiking, and with a series of onboard lectures that cover geology, wildlife, botany, glaciers, and climate change impacts.**

**This classroom-afloat voyage is conducted aboard the M/V Westward, and begins and ends in Friday Harbor, located on San Juan Island. We mix observations aboard with sea kayaking and hiking, and with a series of onboard lectures that emphasize natural history, geology, marine ecology, and regional issues of conservation concern. We are joined during the voyage by a team of divers from the SeaDoc Society, who conduct a live virtual and narrated dive that is transmitted to a viewing screen aboard.**

We delivered our 3rd book--Pacific Flyway: Waterbird Migration from the Arctic to Tierra del Fuego (Audrey DeLella Benedict, Geoffrey A Hammerson, Robert W Butler) to our Seattle-based publisher Sasquatch Books/Random House International on 9/1/2019. Our unique partnership with a mainstream publishing house, with a well-established reputation, distribution, and marketing, enables us to bring award-winning, image-driven books to the public at an affordable price that furthers our science outreach and conservation mission. Cloud Ridge's publishing arm relies on our pro bono science writer, book layout and design specialist, a professional photographic editor, an editor, and a website/communications professional. We donate all royalties received from the publisher to other science nonprofits.

**3:** Yes. After 40 years, we retired our annually scheduled touring program (we began in 1979), and will focus on Cloud Ridge Publishing book projects in the coming years. As of 1/2019, we will rely on our website and will not produce a printed brochure and will rely on our website. We operated 3 "classroom-afloat" voyages (refer to this Form 990 for those details) to honor previous outfitter and client obligations. In the future, we will offer only 1 or 2 seminars each year in support of our publishing program.

**4d. (p. 2):** "Other Program Services" refers only to those activities related to the Cloud Ridge Publishing arm of Cloud Ridge Naturalists. We just released our 3rd book (Pacific Flyway) for our publisher, Sasquatch Books/Random House in February 2020. All the expenses and income figures in this 2019 Form 990 reflect those activities.
