Heirlooms for Hospice, three upscale resale shops, feature treasures donated by the community. Families of those HopeWest has served find comfort knowing the treasures they donate help support HopeWest, and also bring joy to the neighbor who purchases them. Many volunteers in the stores find grief support through their work. Spoons Bistro and Bakery, (full-service restaurant), and the Artful Cup (coffee house and gift shop), located on our hospice campus, serve patients and families receiving care in the Hospice Care Center. They are places known in the community as wholesome gathering spots for receiving information and support. Volunteer Services - People with a passion for helping others make our work possible. 1,246 volunteers gave more than 81,000 hours of time in 2019, adding a value of 39 full time equivalents (FTEs). Gifts of time are as unique as those who contribute. Volunteers change our world by holding the hands of patients in need, providing art and music therapy to patients, supporting kids coping with grief, providing spiritual care, welcoming visitors, beautifying our gardens, creating a one-of-a-kind shopping experience at Heirlooms for Hospice, making our fundraising events special, baking cakes for patients' special celebrations and so much more. The CLUB - The CLUB is a new HopeWest program offered at the Center for Living Your Best. It is a program designed to facilitate seniors' access to services and facilities in order to achieve their goals of living their best. The CLUB includes a variety of amenities designed to provide social support as well as other services including a hair salon (The Curling Iron), barbershop (Whiskers), transportation, a variety of classes including arts & crafts as well as other activities designed to help keep seniors active and engaged in the community.

Community-based hospice care is our largest program, caring for more than 500 patients & their families every day (1800 in 2019) from Ouray to Rio Blanco county across more than 10,000 sq. miles through 5 program offices. Our patients are served by an expert interdisciplinary team including palliative medicine certified physicians and advance practice nurses. More than 1000 volunteers support our patients. Philanthropy is critical to assure no one is turned away due to lack of insurance or complex social needs. It makes hospice possible in frontier communities that would otherwise not be served. HopeWest boasts more than 3 x the national required volunteer hours and has been recognized for its top-quality ratings nationally.

Form 990, Part III, Line 4b:

More than 500 Hospice patients came from other settings to receive expert acute hospice care at our 13-bed care center rather than hospitalization when their symptoms could not be managed at home. The Ferris Care Center provides short-term care in a comfortable, home-like environment for patients and their families in the most difficult times. Our approach to care includes comprehensive physical, emotional, social, and spiritual support for the patient and their family. The Center is staffed with 8 hours of physician time each day and families are supported by a full-time chaplain and family support worker. The Center sits on a 4-acre campus with beautiful grounds maintained by volunteers.

Form 990, Part III, Line 4c:

Community Programs, the third largest area relies solely on fundraising to exist. The Center for Hope & Healing serves grieving adults with one on one counseling & support groups (over 500 served in 2019); HopeWest Kids provides grief support to children ages 3-19 thru school groups, equine therapy, grief camps, and art therapy (759 children served in 2019); and 3 Palliative Care Programs called Transitions, Living with Cancer and Journeys. These programs provide hospice like care for those who have no insurance coverage for the care needed as they do not have a six-month prognosis or want curative care (377 patients in 2019). The programs, provided free or on a sliding scale, are a safety net for the most vulnerable in our community. Our Center for Living Your Best was opened in 2019 focusing on wellness programs for aging individuals.
