Our Adopteen Program serves over 300 adopted American pre-teens and teenagers each year with Adoptween hangouts, summer camp-conferences and giving back orphanage service trips where they spend time working and caring for children in the orphanages. The China Roots Program created opportunities for 186 Adoptees to return back to China to discover their roots and visit the Orphanages where they lived prior to adoption. With these 186 Adoptees, 297 of their family members were able to join in and take advantage of this program resulting in a total of 483 persons touring China.
