THE POWERHOUSE WELCOMED NEARLY 30,000 VISITORS TO THE SCIENCE CENTER GALLERY IN 2019. ACCOMPLISHMENTS FOR THE YEAR INCLUDE LAUNCHING THE TINKERLAB AS A HANDS-ON INTERACTIVE SPACE FOR ELEMENTARY-AGED CHILDREN AND DEVELOPING AN OUTDOOR GARDEN SPACE FOR VISITORS. GOALS FOR 2020 INCLUDE HOSTING TEMPORARY EXHIBITIONS FROM THE SMITHSONIAN, NASA, AND THE AMERICAN MUSEUM OF NATURAL HISTORY AND DEVELOPING ADDITIONAL OUTDOOR ACTIVITIES TO ALIGN WITH COVID RECOMMENDATIONS AND GROWING MEMBERSHIP SUBSTANTIALLY.

WE EXPANDED CAPACITIES BY BUILDING OUT A METAL LAB AND JEWELRY MAKING STATION. WE OFFERED ADULT-FOCUSED CLASSES ON WELDING, BLACKSMITHING, WOODWORKING, LASER CUTTING, PROGRAMMING, CNC ROUTING, MACHINING, 2D AND 3D MODELING, AND JEWELRY MAKING AND HOSTED HIGH SCHOOL STUDENTS FOR SKILL-BASED INTERNSHIPS. CAMP DISCOVERY, OUR DAY CAMP PROGRAM, PROVIDED STEM ACTIVITIES TO 290 ELEMENTARY AND MIDDLE SCHOOL CHILDREN DURING THE SUMMER RECESS.
