MISCELLANEOUS EXPENDITURES: Funds were utilized to enhance the patient experience and to meet community needs in a variety of ways. Funds raised for charity care in Big Sky were transferred for Big Sky Medical Center. Grant funds enhanced behavioral health services, including covering salary and benefits for a patient navigator and LCSW for our Integrated Behavioral Health program. Patient Care funds helped cancer patients in need. A grant from Kendeda Fund covered expenses for our Healthcare Connections program and community outreach. Funds were transferred from the Cancer Patient Care fund to rent rooms from Hillcrest for cancer patient housing needs. The Act Now Diabetes program continued strong operations. The Chaplin program at Hillcrest was covered through charitable donations, and the Good Sam fund provided taxi vouchers, hotel rooms and additional support for those in need.
