Five apartment units are occupied by individuals and families in the low- and very-low-income brackets: in 2019, a family of 7, a family of 2 with a roommate, two couples and one single person. Personal relationships with tenants provide practical and emotional support. Each tenant household is invited to have one member on the Board of Directors, empowering tenants to participate in decisions affecting their lives. Two tenants chose to serve on the Board in 2019. In 2018, Emmaus Housing purchased and renovated a four-bedroom house, which is rented to the Denver Catholic Worker to house people currently experiencing homelessness. One family of 2 and 2 single persons lived in the house in 2019. The Catholic Worker is waiting for zoning approval to add an additional family of 4.
