WE PROVIDED RESOURCES ABOUT COMMUNITY ORGANIZATIONS AND GROUPS THAT OUR ATTENDEES MAY BE INTERESTED IN AT OUR EVENTS. SOME OF THE EDUCATIONAL TOPICS COVERED IN 2019 WERE COLLEGE 101 FOR LGBTQ YOUTH, MENTAL HEALTH IN THE LGBTQ COMMUNITY, PREP & HIV INFORMATION AND TESTING, LGBTQ ADOPTION & FOSTER PARENTING, SPIRITUAL HEALTH, AND TRANSGENDER CARE AND RESOURCES. WE HAD AN LGBTQ PROM WITH LOCAL ORGANIZATIONS PROVIDING INFORMATION ON RESOURCES AVAILABLE TO YOUNG PEOPLE WHICH WAS ATTENDED BY 325 INDIVIDUALS. WE HAD OPPORTUNITIES FOR LGBTQ PEOPLE AND THEIR FAMILIES TO SOCIALIZE AND CREATE A SENSE OF CONNECTION AT A TINCAPS MINOR LEAGUE BASEBALL GAME (ATTENDED BY 120), BOWLING EVENT (TOTAL ATTENDANCE OF 140), AND SKATING PARTY (ATTENDED BY 170). OUR FESTIVAL, ATTENDED BY THOUSANDS, HAD A VENDOR MARKET WITH OVER 60 ORGANIZATIONS REPRESENTED OFFERING INFORMATION ON THEIR SERVICES PROVIDED. LOCAL BUSINESSES AND LGBTQ AFFIRMING CHURCHES WERE ALSO PRESENT IN THE MARKET PROVIDING INFORMATION ON THEIR SERVICES. WE HAD AN EDUCATIONAL WORKSHOP TENT FROM NOON-7PM ON THE SATURDAY OF THE FESTIVAL. FORT WAYNE PRIDE ALSO HAD A DAY OF SERVICE WHERE 50 COMMUNITY VOLUNTEERS CAME OUT TO CLEAN UP A LOCAL PARK IN HONOR OF THE PULSE NIGHTCLUB MASSACRE. WE PARTNERED WITH A DOZEN LOCAL LGBTQ AND ALLY ORGANIZATIONS TO HOST MONTHLY MEETINGS TO FIND WAYS TO ADDRESS GAPS IN SERVICES THAT EXISTED IN OUR AREA. IN 2019, NEARLY 200 LGBTQ PEOPLE WERE CONNECTED WITH RESOURCES THEY OR THEIR FAMILY NEEDED INCLUDING REFERRALS TO PFLAG (PARENTS, FAMILY, FRIENDS OF LESBIANS AND GAYS), CENTER FOR NONVIOLENCE, LOCAL HOMELESS AND DOMESTIC VIOLENCE SHELTERS (INCLUDING FINDING PERMANENT HOUSING FOR AN INDIVIDUAL THROUGH THE SALVATION ARMY), POSITIVE RESOURCE CENTER (FORMERLY AIDS TASK FORCE), MENTAL HEALTH PROFESSIONALS, LAWYERS AND PHYSICIANS. WE ALSO WORKED WITH THE CENTER FOR NONVIOLENCE TO CONTINUE THEIR SUPPORT GROUP FOR LGBTQ INDIVIDUALS OVER 21 AND A YOUTH GROUP FOR LGBTQ UNDER 21. WE CONTINUED OUR WORK BUILDING AN ONLINE RESOURCE DIRECTORY FOR LGBTQ PEOPLE IN OUR COMMUNITY TO FIND SAFE, AFFIRMING ORGANIZATIONS AND BUSINESSES. WE USED THE MULTIPLE EVENTS AS A WAY TO BRING VARIOUS CONNECTED COMMUNITIES TOGETHER TO HEAR FROM VARIOUS SPEAKERS, EXPERTS AND Q&A'S TO SOLVE SOME OF OUR LOCAL COMMUNITY'S PROBLEMS. IN 2019 THE ORGANIZATION DELIVERED DIVERSITY TRAINING TO ALL THE NEW FORT WAYNE POLICE OFFICERS WHO ENTERED THE FIELD. TALKS ARE UNDERWAY TO TRAIN ALL OFFICERS IN THE NEXT COUPLE OF YEARS, BUT THE ACADEMY TRAINING WILL CONTINUE ANNUALLY. FORT WAYNE PRIDE WORKED WITH MEMBERS OF MULTIPLE CHURCHES AND ORGANIZATIONS TO "SPONSOR" LGBT FAMILIES IN NEED IN THE HOLIDAY SEASON, PROVIDING GIFTS AND HOUSEHOLD SUPPLIES TO 12 FAMILIES WITH 48 FAMILY MEMBERS BEING HELPED.
