The organization offers interactive training and intensive coaching or digital organizing techniques and career readiness. Fellows learn to manage volunteers, lead trainings, tell their own stories, and move others to action. Then, they receive personalized career coaching, resume and cover letter help, and connections to future employers. In 2019, the Organization launched a civic engagement fellowship, developed application and early-stage training materials, built a database of over 10,000 campus contacts for fellowship recruitment and recruited a team of 10 student volunteers, trained them on outreach and selection strategies.
