The staff of his law firm provides basic bookkeeping services to the organization. Questions are discussed with the organization's President during the preparation process. The final draft of Form 990 is sent to each Board member for review prior to the President signing and filing the Form. Time is given for Board members to review Form 990 and to ask questions, suggest changes, corrections or additions to the Form prior to the President signing and filing the Form.
