ADULT MENTORS HOSTED 12 COMMUNITY BASED ACTIVITIES IN ADDITION TO FACILITATING YOUTH ATTENDANCE AT THREE STATEWIDE EVENTS: SPRING ENCUENTRO, YOUTH SUMMER CAMP, AND THE CONGRESO DE LAS ACEQUIAS. THE YOUTH CAMP WAS THE FIRST EVER FOR THE NMAA AND INCLUDED HANDS-ON ACTIVITIES SUCH AS MAKING HERBAL REMEDIES, ART, POETRY, AND MUSIC. DURING 2019, THE NMAA ALSO INITIATED A YOUTH EDUCATION PROJECT INVOLVING NUMEROUS LOCAL SCHOOLS. NMAA STAFF DEVELOPED PRESENTATIONS AND EDUCATIONAL MATERIALS THAT WERE TAILORED FOR ELEMENTARY OR MIDDLE/HIGH SCHOOL AND CONDUCTED OUTREACH TO SCHOOLS AND ORGANIZATIONS ACROSS THE STATE TO BUILD RELATIONSHIPS WITH EDUCATORS AND ADULT MENTORS. AS A RESULT, OUR TEAM GAVE 86 PRESENTATIONS THAT PROVIDED YOUTH WITH A BASIC OVERVIEW OF ACEQUIAS, AGRICULTURAL TRADITIONS, WATER ISSUES IN NEW MEXICO, AND SEED SAVING. PRESENTATIONS WERE GIVEN IN SCHOOLS AND ORGANIZATIONS REACHING OVER 3,800 STUDENTS. LOS SEMBRADORES AND FARMER/RANCHER OUTREACH: IN 2019, NMAA IMPLEMENTED ITS SECOND YEAR OF LOS SEMBRADORES FARMER TRAINING PROJECT INTENDED TO PROVIDE INTENSIVE TRAINING FOR NEW AND BEGINNING FARMERS. THE PROGRAM CONSISTED OF TWO CO-TRAINERS AND TWO APPRENTICES WHOSE WORK COVERED A TEN-MONTH PERIOD TO LEARN SMALL-SCALE AGRICULTURAL PRODUCTION ON ACEQUIA FARMLAND, FARM VIABILITY AND BUSINESS PLANNING, AND THE CULTURAL ASPECTS OF ACEQUIA AGRICULTURE INCLUDING ACEQUIA MAINTENANCE, WATER SHARING, AND STEWARDSHIP. THE GOAL IS FOR EACH APPRENTICE TO GAIN THE KNOWLEDGE AND SKILLS TO OPERATE A SMALL FARM OF THEIR OWN UPON COMPLETION OF THE PROGRAM. DURING THE COURSE OF THE YEAR, THE PROGRAM INCLUDED INSTRUCTIONAL DAYS 3 DAYS A WEEK FOR 10 MONTHS. TRAINERS AND APPRENTICES WORKED ON A SMALL FAMILY FARM AND LEARNED SKILLS AROUND SOIL HEALTH, SEASON EXTENSION, IRRIGATION, BED PREPARATION, WEED CONTROL, HARVESTING, COLD STORAGE, FOOD PRESERVATION, AND FARM BUSINESS PLANNING. AFTER THE COMPLETION OF THE PROGRAM, EACH OF THE THREE HAVE CONTINUED THEIR FARMING ACTIVITIES INCLUDING, FOR EXAMPLE, ESTABLISHMENT OF AN ORCHARD, GROWING A FAMILY GARDEN, AND WORKING AT A HIGHER EDUCATION
