In the time period September 2019 to December 2019, DreamTree Project has served 89 people in need of a place to stay. On leaving the programs, over 80% of residents moved into transitional or permanent housing situations. DTP undertook multiple new initiatives: staff completed a housing development training series; began the planning process for hosting an AmeriCorps program for young people; and assisted with the first-ever homeless memorial in Taos. In December, DTP hosted the Festival of Trees as a holiday gala and fundraising event.
