THE CLINICAL RESEARCH PERFORMED BY OUR PRINCIPAL INVESTIGATORS CONTRIBUTED TO SCIENCE AND IMPROVED HEALTHCARE FOR OUR MILITARY VETERANS. DURING 2019, THE FOUNDATION DIRECTLY SUPPORTED RESEARCH RELATED TO THE USE OF SMARTPHONES TO IMPROVE DIABETIC LIFESTYLES, A DOD-FUNDED STUDY FOR VASCULAR DYSFUNCTION AND VASCULAR INFLAMMATION IN TBI-MEDICATED COGNITIVE DYSFUNCTION, AND A VARIETY OF VETERANS ADMINISTRATIVE PROJECTS TO INCLUDE STUDYING C-DIFFICILE, COLLECTING SAMPLES FOR A DATABASE, AND TESTING LUNG FUNCTION. SPECIFICALLY, DR. PETER REAVEN CONDUCTED A STUDY IN COLLABORATION WITH ARIZONA STATE UNIVERSITY, TO TEST HOW SMARTPHONE USE WOULD IMPACT VETERANS WHO HAVE DIABETES.
