In recent years, our clients have seen professional counselors for help with family/interpersonal issues, substance abuse concerns, anxiety and depression, grief or loss, on river and work related issues and transition issues. During the year, 64 clients sought assistance through the confidential 24/7 helpline staffed by licensed counselors. Many were then referred to licensed, case management counselors. On-going counseling sessions with 13 counselors totaled 252 hours during the year, without charge to clients, similar to the prior year. The organization received reduced rates from the counseling professionals. Quarterly articles describing these available services and the other services described below were published throughout the year in Grand Canyon River Guides publication, Boatmans Quarterly Review.

During the March 2019 annual Guides Training Seminar at Marble Canyon, AZ hosted by Grand Canyon River Guides, a nonprofit organization, over 70 clients participated in free physical health screenings provided by 12 health care professionals. Over 400 of these services were provided without charge in-kind to the organization reflected in the financial statements. Clients received follow-up lab work at no charge. During 2019, 20 clients received stipends averaging 562 each and totaling 11,250 to help secure and maintain health insurance policies.
