WE KNOW THAT THE ER IS THE MOST EXPENSIVE FORM OF HEALTH CARE AND THOSE UNPAID ACCOUNTS RESULT IN THE RISING COST OF HEALTH CARE FOR THE POPULATION AS A WHOLE. DR. VOLZ RESEARCHED THIS TOPIC IN GREAT DETAIL WONDERING HOW OTHER COMMUNITIES ARE ADDRESSING THIS ISSUE. ITS MISSION IS TO PROVIDE PRIMARY MEDICAL CARE, AND TO UNDERSTAND THE HEALTH AND WELLNESS NEEDS OF THE MEDICALLY UNDERSERVED AND THEIR HOUSEHOLD MEMBERS WHO LIVE OR WORK IN TETON COUNTY, WY. THE TETON FREE CLINIC WAS GIVEN A GENEROUS DONATION TO PROVIDE THE INITIAL FUNDING, AND IS NOW SUPPORTED BY DONATIONS MADE MOSTLY THROUGH 2 LOCAL FUNDRAISERS. THE CLINIC OPERATES ONE EVENING PER WEEK. IT IS STAFFED BY AN EXECUTIVE DIRECTOR, AND A PHYSICIAN ASSISTANT WHO RECEIVE A SMALL STIPEND TO ENSURE CONTINUITY OF CARE AND MANY OTHER VOLUNTEER PHYSICIANS, NURSES, SOCIAL WORKERS, AND LAY VOLUNTEER COMMUNITY MEMBERS. THE CLINIC SEES APPROXIMATELY 750 PATIENT VISITS PER YEAR. PATIENTS MUST PROVIDE DOCUMENTATION STATING THAT THEY ARE RESIDENTS OF TETON COUNTY, WY, DO NOT HAVE HEALTH INSURANCE AND MEET THE INCOME GUIDELINES. SERVICES THAT ARE OFFERED ARE SIMILAR TO THOSE OF ANY PRIMARY CARE FACILITY; TREATING A WIDE RANGE OF DIAGNOSES FROM DIABETES TO HYPERTENSION AND MINOR ACCIDENTS. MOST LABORATORY AND RADIOLOGY TESTS ARE COVERED AS WELL AS PRESCRIPTIONS. THE CLINIC'S THEME IS THE CIRCLE OF CARING AND GIVING. WE ASK EACH PATIENT TO RECOGNIZE THAT THE SERVICES THEY RECEIVE ARE A GIFT TO THEM OUT OF LOVE AND CONCERN FROM THEIR COMMUNITY AND THEY ARE IN TURN ASKED TO OFFER AN ACT OF KINDNESS TO SOMEONE THEY ENCOUNTER IN LIFE WHO</p>
