GACE was created to fulfill a mission to empower African communities through the advancement of fair trade, education, sustainable living, and gender equality. We partner with Alaffia enterprise to combat poverty and to advance gender equality through direct, long-term programs in maternal health, education and environment in West African rural communities.

Safe Births Maternal Health Project: GACE funded 485 women in 2019 in our program to provide antenatal, delivery and post natal care for extremely poor mothers and babies in Togo, West Africa. Our staff partner with national health clinics, traditional leaders, local leaders, and community volunteers. GACE provides services including managing enrollment books, receiving, paying, and recording billing records for beneficiaries and ensuring each woman receives copies of all her health care records, including tests, diagnoses, vaccinations, and other treatments. GACE staff help ensure beneficiaries receive all prescribed care. In addition to direct services, the Safe Births program trains every beneficiary in women's and family health concerns, including mother and infant nutrition, breastfeeding, sanitation and hygiene, birth spacing, and impacts of female circumcision (FGM).

Bicycles for Education: GACE collected 830 bicycles from Everett, WA to Corvallis, OR, many of which would otherwise have gone to US landfills. GACE shipped, repaired & donated 397 bicycles in 2019 to extremely poor secondary school students in Togo. Our Bicycles for Education program addressed the extremely high dropout rate in rural West Africa. 80% of boys and 90% of girls in Togo do not graduate secondary school. In rural areas the distance, family chores, and lack of transportation are key barriers to education especially for girls who are burdened with daily chores like fetching wood and water, or gardening. 95% of our bicycled students are staying in school or graduating. In 2019, GACE sold 12 bicycles to help fund the overseas shipping costs.

School Construction Program: GACE constructed a kindergarten in the town of Kaboli Togo in 2019. Investing in early education is a powerful way to reduce the disadvantage of low economic status and gender discrimination. Only 1 in 4 children attends a preschool program in Togo, even fewer in rural areas. Access to kindergarten is critical as they are steppingstones out of exclusion from education. Kindergartens that do exist are often held in temporary structures that do not offer real protection from the environment. GACE works with regional and local education authorities, community leaders, and donor partners to build schools for qualifying public school districts in rural areas of Togo.
