28 Guatemala social service projects focused on improvement of education and health support for indigenous Maya and urban marginalized populations. The following 6 areas were supported: 1.) CEMIK, a small school that supports 120 Maya Ixil children ages 4 to 12. Curriculum focuses on literacy in Ixil and Spanish, Indigenous rights, culture and health. Funds go to pay for school supplies, a nutritious meal for each child, three teachers salaries, educational excursions and school maintenance. mundo has supported this project for 14 years. 2.) ASEPA, an adult literacy program based in the outlying marginalized areas of Guatemala City. Mundo funded 4 instructor salaries for this program that serves over 300 women, many of them over the age of 50 receiving an education for the first time. 3.) Mundo paid for the transportation and fees for 15 children to receive consultation and surgery for physical disabilities including club foot, cleft palate and eye disease. These are life changing surgeries for these children who rely on their physical prowess to tend to the corn fields, carry wood, etc. 4.) Mundo gave a grant to the Pal, Quiche public school so that they could purchase a property where the children can play soccer and the town can congregate for meetings and events. We also provided school supplies. Aproximately 90 children attend the k-5 school. There are 125 families living in this remote village that can only be reached by foot or horse. 5.) Mundo provided grants to the ICM Catholic Sisters who run a nutrition program for children 0-5. Funds went to support 100 children with supplemental food supplies in order to combat the rampant malnutrition. 6.) Mundo also gave a grant to ACEFOMI, an NGO in Guatemala run by women to provide women with mental health workshops as well as workshops on indigenous and human and reproductive rights, health and well-being of children. These workshops assisted 135 participants. A grant was also given to the group to learn how to grow nutritious mushrooms.	28a	21,996
