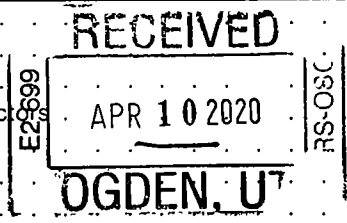





Part III- Organization's Primary Exempt Purpose

The agency is an international medical care and teaching organization. We believe every woman should have the opportunity to be healed from the devastating effects of childbirth injuries. Our focus is on repairing obstetric fistulas and other pelvic floor disorders through surgery, as well as training local doctors in these life-saving techniques. Our medical team is composed of U.S. doctors & nurses volunteering their time. All services are provided free of charge.

Part III, Line 28 - Statement of Program Service Accomplishments

Forty Eight (48) women received surgery / medical care from Medicine For Humanity in 2019.

Six (6) Ugandan resident physicians received FPMRS surgical training in 2019

Twenty - Five (25) Ugandan physicians and twenty- four (24) Ugandan medical students received 12 hours of medical lectures.

One (1) Ugandan resident physician was awarded the Urogynecology Leadership Fellowship, which provides a full year of paid surgical training.
