AUTHORIZATION FROM THE CENTERS FOR MEDICARE AND MEDICAID SERVICES (CMS) AND THE WASHINGTON STATE DEPARTMENT OF SOCIAL AND HEALTH SERVICES AGING AND LONG-TERM SUPPORT ADMINISTRATION (DSHS-ALTS) MAKE THE OPERATION OF ICHS PACE POSSIBLE.
