EVERGREEN HEALTH INSURANCE PROGRAM: LIFELONG'S GOAL IS HEALTH EQUITY FOR ALL: WE BELIEVE THAT EVERYONE SHOULD HAVE FAIR AND EQUAL OPPORTUNITIES TO REACH THEIR FULL HEALTH POTENTIAL. THROUGH OUR EVERGREEN HEALTH INSURANCE PROGRAM (EHIP), WE HELP PEOPLE ACCESS HEALTH INSURANCE AND THE MEDICATIONS THEY NEED TO GET HEALTHY AND STAY HEALTHY.
