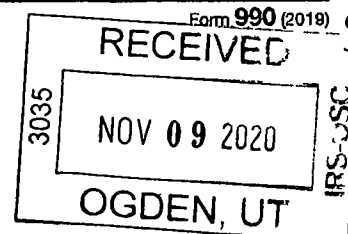

Training is made available to an array of individuals and counselors through classes, conferences, and certification for professional counselors. The program strives to provide specialized training for counseling problem gamblers and family members to increase counselors' effectiveness in helping individuals overcome a gambling addiction or its negative effects on the family. The program also offers certification and training to individuals who are responsible for furnishing treatment services to those who have been identified as having a gambling addiction. Responsible Gaming training is available for gaming industry employees at both the management and frontline staff levels.

4b (Code:) (Expenses \$ 269,748 including grants of \$ 0) (Revenue \$ 75,627)**Education/Outreach/Youth Services:**

Public education focuses on helping individuals and the community at large to identify and prevent gambling addictions. This is accomplished by making problem gambling information and resources available to the general public, including resources for treatment and support services. The information is available via the Council's website in electronic download as well as in print and video form. The Council operates a speaker's bureau to conduct public awareness presentations throughout the state. The bureau is available at most venues including schools, businesses, civic councils, and agencies within Washington state and other regions. The Youth Services program is designed to assist youth in making healthy choices and reducing risky behaviors. Youth Services also includes an arts-based program, New Directions, to help youth become aware of the potential negative effects of gambling addictions and to also become aware of alternate healthy choices in entertainment and recreational activities.

4c (Code:) (Expenses \$ 114,186 including grants of \$ 66,003) (Revenue \$ 0)**Treatment/Therapeutic Justice:**

The treatment and therapeutic justice programs include both residential and outpatient treatment services for problem gamblers. These treatment services are available to all individuals within the state who are striving to overcome gambling addiction. Outpatient treatment services are also available for family members living in Washington who are affected by gambling addiction. A treatment provider manual has been developed with tools and forms for service providers to deliver services to problem gamblers.

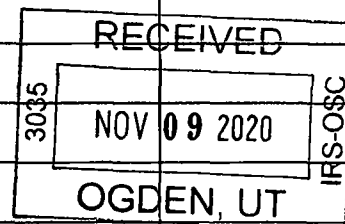

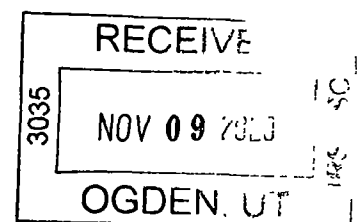

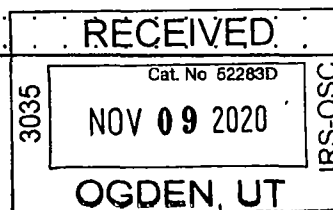
