STRATEGY, PLANNING & CAMPAIGN SUPPORT. AJS worked with several community-based organizations to support internal & external development. AJS helped Citizen Action of NY do an internal organizational assessment & planning process that built a stronger governance plan, supported the development of a communications strategy & supported a new organizational leadership team. AJS worked with Virginia Organizing to build on its commitment to racial justice by developing a racial justice curriculum that focuses on the history of racism & resistance in VA & created a leadership discussion about advancing a racial justice agenda. This process engaged over 150 community leaders. AJS also provided training & support for 18 interns. AJS worked with Manufactured Housing Action to develop regional leaders that understand the racial dynamics in their communities & focused their organizing, outreach, campaign planning & activities to integrate their racial justice goals. AJS work included curriculum development, 3 site based trainings that engaged 127 leaders & ongoing staff consulting (see Sch O)

WE ARE DOWN HOME. This year, WDH members created new tools to build power for poor & working folks in NC. Access to affordable healthcare is a top priority. Over 1,500 people worked together for Medicaid expansion. They held town halls, wrote letters, participated in a statewide vigil, went door-to-door & were present when the Governor stood with working people & vetoed the state budget. Canvassing is another way that WDH members speak truth to power. From Sept to Nov, members in Alamance Co held over 1,000 conversations with voters, using their own stories to build solidarity around immigration & healthcare. Also in Alamance, members created & raised nearly \$16,000 for a Community Bail Fund & assisted in freeing 5 people so far to fight the unjust system of cash bail. The same group began a member-led court monitoring program. During the summer, WDH established a Syringe Exchange Program in western NC & distributed over 130 overdose reversal kits. WDH broke ground in Cabarrus Co by knocking on almost 2,500 doors in a listening canvass. WDH now has a membership over 2,000 strong.

NATIVE ORGANIZERS ALLIANCE. NOA conducted community organizing trainings for tribal entities and Native groups which engaged over 1700 participants. The trainings were a part of the ongoing support of local groups working on environmental justice, health, gender justice, tribal sovereignty and voter protection. NOA also co-hosted the first ever Native Presidential Forum, August 24-25, 2019 providing a forum for tribal and Native community leaders to question and educate 11 presidential candidates on issues affecting Indian Country.
