

All receive grants and fees for services. The medical fund and health savings pool assist uninsured and under insured jazz musicians with emergency medical expenses, the scholarship lesson fund subsidizes tuition and lessons for children and their families as well as providing two \$1000 scholarships through the Western Washington University Foundation; the instrument fund accepts and refurbishes musical instruments to loan out on no-fee long-term leases to students; and the Out of the Ashes music therapy program provides support for a weekly music program for children and adults with moderate to severe cognitive, emotional, and physical disabilities.
