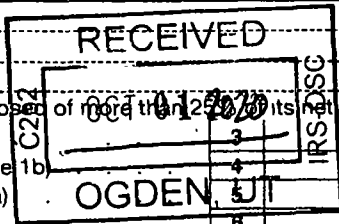

In 2019, there were five institutions that received a total of \$14,880 for these scholarships. In addition, the organization hosts a leadership conference (OPNA - Olympic Peninsula Nonprofit Alliance). In 2019, OVCF provided \$2,070 in funding for this program. Also in 2019, OVCF hosted the Clallam Gives program and distributed \$4,780 to various organizations whom were the designated recipients of these community giving programs. For 2019, a total of \$35,002 was distributed to nonprofit organizations. No single organization received a grant equal to \$5,000 or more.
