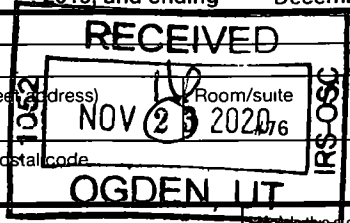

Siyafunda Conservation Initiative: Siyafunda is located in the Makalali Game Reserve, a 60,000 acre reserve in the Limpopo Region of South Africa, near the Kruger National Park. Siyafunda was initially established to assist with existing research projects and provide valuable data to the reserve management of Makalali Game Reserve. Today the research data gathered by the volunteers and staff at Siyafunda is not only used by Makalali Reserve, but provided to students, researchers and other national conservation projects, including the Endangered Wildlife Trust (EWT). The volunteers this year have continued their vital monitoring and data collection of the Elephant population. The Elephant Contraception Program initiated at Makalali has been for years the benchmark for many other reserves who wish to control their elephant populations without culling. In addition the volunteers have been instrumental in monitoring the herd of 50 disease free buffalo that was released into the open reserve in 2019. They are closely observing the integration of the buffalo into the whole of the reserve, to include noting their feeding habits, breeding and 1st time interactions with predators. The Lion Foundation sent approximately 150 volunteers who contributed their time and over \$87,000 to Siyafunda in 2019.

Kariega: Located in the Eastern Cape of South Africa, Kariega is a 25,000 acre game reserve home to all of the Big Five animals. Volunteers at Kariega learn about conservation while engaging in a wide range of tasks. The key areas of focus for the reserve are lion, elephant and rhino research. The volunteers learn radio telemetry to assist in tracking and locating these animals, in order to monitor their feeding and traversing habits. In addition, volunteers have been involved in the serval breeding project and took part in the release of 2 servals and 2 African wildcats. Volunteer monitoring by the volunteers indicated that both were adapting well and surviving in their new habitat. The Lion Foundation sent 25 volunteers who contributed \$16,000 to Kariega in 2019.

Included in Lion Foundation revenues are additional loans from L. Kelcey Grimm in the amount \$6,500 and a loan from Camilla Grimm of \$10,000. The Lion Foundation paid back the \$6,500 loans to Kelcey and \$5,050 of the loan from Camilla Grimm. It also paid down its debt to L. Kelcey Grimm on the loan payable to her by \$47,335 while setting up an additional \$18,733 in interest due to her. The net result of these entries is Lion Foundation debt was reduced from \$278,748 to \$255,096.
