United Way of the Mid-Willamette Valley works collaboratively throughout Marion, Polk and Yamhill Counties to identify community needs, and direct resources toward partnerships and programs that will result in the most successful long-term outcomes. United Way strives to improve lives by supporting several unique initiatives that strengthen our community and provide valuable resources for individuals, families and organizations. United Way supports local nonprofits work with resources including volunteers, goods and materials, advocacy and where strategies align funding. This collective approach has shown to improve results and United Way applies these concepts in the areas of education, homelessness, and other critical issues to ensure the community achieves greater and greater success. Here are a few examples of what we have accomplished during 2019:Access to basic hygiene is a recurring issue for those people affected by homelessness. During 2019, with donor support and working in partnership with ARCHES, United Way purchased a 22-foot Mobile Shower trailer that will be driven to locations across the Mid-Valley region. Villages United is a community based membership organization started in 2019 focused on helping seniors live independently in their own homes as they age. This new non-profit has joined a national movement working to help seniors live active, healthy lifestyles. It is estimated that over 450 women are living on the streets in Marion County at any given time. These women are subject to increased risk of assault, rape and robbery every day. United Way is working to change that. At the end of 2019 and with the support of our community partner, Inside Out Ministries, United Way launched a new overnight shelter for women. SafeSleep will provide a safe, warm, secure place for women to sleep, eat and have access to wrap around supports that increase their chances of rebuilding their lives.

Good360 Program:As the regional distribution hub for the national Good360 program, United Way of the Mid-Willamette Valley has relied on this vital resource to enhance its call to action to support our nonprofit service providers. Our investment in a full-time manager, a delivery truck, and an 8,000 square foot warehouse increased our ability to distribute donated goods from area businesses. Our Good360 Gifts-In-Kind program grew exponentially this year with budding relationships with the Amazon Distribution Centers in our region.As we approach the next phase of growth for this program, we continue to refine and improve the Good360 Gifts In Kind program to build a sustainable and robust resource for our nonprofit providers, schools and faith-based organizations.

Grants are accepted online and presented to the board of directors with a summary of available funds. United Way requires funded organizations to submit two reports during the funding period, one at 6-months after the award date and a final report at the year anniversary. The reports ask the organization to provide narrative and detail describing how grant monies were used, how the funding impacted the communities served, outputs created, number of partners involved in the project(s), what outcomes were achieved, how sustainability was created to maintain the project(s) ongoing and the number and demographic of clients served. The Resource Development Director and COO review the reports submitted by the grantees. If a grantee is underperforming, a remediation plan is created. The directors review and provide recommendations to the board when grantees fail to fulfill grant outcomes or fail to complete required reports. In addition, funded partners are required to provide financial reports and documents as part of their year-end report. United Way/Willamette MBA Community Grant PartnershipIn 2019 United Way partnered with Willamette University's Philanthropic Investment for Community Impact program by contributing \$100,000 to be allocated through community grants that support United Ways funding initiatives. The program operates under the externally facing name of the Willamette MBA Community Grant Program since the course was launched in the fall of 2016. This course is a central component of Willamette MBAs not-for-profit management concentration and helps build future leaders in the sector. Each academic year, a new cohort of second-year MBA students oversees the Willamette MBA Community Grant Program and designs a competitive grant cycle. While there is some continuity year over year, each cohort is unique in background, personality, and approach. Each cohort chooses their mission, vision, values, and principles which serve as a guide for decision making. They also choose their own funding areas and criteria for evaluation. To inform these decisions, they learn from not-for-profit leaders and learn about the issues affecting Marion, Polk, and Yamhill counties. The program uses a two-step application process starting with a letter of intent open to all organizations. After an initial review, select organizations are invited to complete a full proposal. Students review applicants on several criteria, including an evaluation of leadership, organizational capacity, indicators of project/program success, and financial health. Finalists are invited to host an onsite visit. Final evaluation of applicants occurs in March, and grantees are awarded in April. Students then follow up with grantees 6-months and 12-months after funds have been awarded.
