(2) Once the funds have been transferred to a project outside the US, the ICC board may make as many on-site visits as possible and necessary. This ensures accountability that things are operating according to accepted procedures. During such visits, project administration will be expected to produce financial reports, receipts and other financial information for inspection at the request of the ICC representative. The project administration must be available to review the records with the ICC representative and provide expense justification. (3) Any international project receiving ICC grants will need to prepare and submit a financial report that contains information which includes funds received from ICC. These reports are to be sent to the ICC Finance Director for review.
