IN 2018 WE CREATED SEVERAL NEW EXHIBITS INTERNALLY INCLUDING ONE LARGE EXHIBITION ON THE SPECIALTY METAL INDUSTRY IN ALBANY. FOR PROGRAMING WE CONTINUED A HIGHLY SUCCESSFUL HISTORY BITES SEEING ATTENDANCE INCREASE TO AN AVERAGE OF 50 PER EVENT. WE BEGAN A NEW FIRST FRIDAY PROGRAM OFFERING POP-UP ART EXHIBITS AND EXTENDED HOURS TO THE COMMUNITY ONCE A MONTH.
