We work to make sure the communities most directly affected by inequities are at the head of the table. In 2019 we had over 800 individuals sign-on to anti-hate actions. Over 113 resources in our In Indigenizing Love toolkit. 1 workbook, 2 modules, 3 Two-Spirit leadership profiles, 7 activities, over a 100 links, videos and other resources

The Developing Leaders Program provides training, leadership development, and organizational capacity support to social movements and leaders committed to diversity, equity, and inclusion. In 2019, we had 33 fellows in our first cohort creating new approaches to gender justice, inclusive democracy, and countering antisemitism and 153 presentations and workshops reaching over 26,000 people

The Shifting Culture Program works to convene culture makers to shift the narrative and use culture as a vehicle for base- and power-building in non-traditional social change spaces. The stories we tell are critical to helping people envision a pluralistic world in which everyone can live, love, and work free from fear. As divisive narratives reinforce a fear of the other, we're partnering with artist and culture makers to tell a different story, one in which everyone has a stake. In 2019, we had over 250 mentions of Western States Center in the news and over 8200 requests for the Confronting Whist Nationalism in Schools toolkit from every US State, Puerto Rico, the District of Columbia & 18 countries
