Conservation advocacy for marine biodiversity and the resilience of coastal communities. We conduct public education events, support two grassroots groups involved with Oregon's nearshore marine reserves (Cape Falcon MR & Cascade Head MR) Our work was conducted by Coast Range Association staff person Jim Carlson. The Marine Program directly serves the people of Lincoln, Tillamook and Clatsop counties. During 2019 we began building a marine communications component that will center on radio interviews and an Ocean News electronic newsletter. Chuck Willer and Jim Carlson conducted 3 community talks on oceans & climate change.

990EZ Part III, Line 29 Private Lands Forest Management

Public interest research and advocacy for sustainable forest management and the climate related need for forest carbon sequestration. Coast Range Association staff person, Chuck Willer, spoke at nine community events presenting research on private forest management practices, the climate emergency and the role of forests related to the need to sequester atmospheric carbon driving global warming. We began the electronic newsletter, CRA News, reporting on our work and the work of colleagues. 90EZ Part III, Line 30 Public Lands Management

We continue our long advocacy addressing the conservation of native forest and the protection of aquatic values on federal lands. This work focused on upholding key federal forest laws regarding land management planning by the BLM. We believe the agency erred in the development of its Western Oregon forest management plan. We are in federal court seeking relief as a plaintiff. We are involved in numerous discussions and support activities urging federal forest officials to adhere to the Northwest Forest Plan.
