Food service to low income and homeless individuals through out the Old Town district of Portland. 175 meals served 3 times each week in addition to 50 meals to the homeless living further out in the warehouse district.

Life sustaining services for those living in the streets. Three times each week we travel through out the homeless district of Portland caring for basic living essentials. Through providing blankets, first aid and all the essential items necessary for surviving homelessness we begin a process for permanently changing lives. The mentally disenfranchised require great attention to begin the process of social service for success through this process. In addition to all the supplies necessary for this operation, a local business donates storage and office space freeing our finances to expanding help for all those in need.

There is a farm providing extensive therapy for addressing all the issues which originally created the position we find each for those living in the streets.
