FAMILIES COME TO WEEKLY WORKSHOPS ON A VARIETY OF SUBJECTS BASED UPON THEIR INDIVIDUAL NEEDS FOR AS LONG AS NECESSARY TO KEEP THEM SUCCESSFULLY IN THEIR HOMES.
