SECTION 3.4 OF THE FOUNDATION'S BYLAWS WAS DELETED AND REPLACED WITH NEW SECTION 3.4 AS FOLLOWS: 3.4 TERM AND ELECTION. THE TERM OF OFFICE FOR DIRECTORS SHALL BE THREE YEARS. A DIRECTOR SHALL SERVE NO MORE THAN THREE CONSECUTIVE FULL TERMS UNLESS IT IS TO SERVE OUT THE REMAINDER OF HIS OR HER TERM AS CHAIR OF THE BOARD OR AS AN OFFICER. THE BOARD OF DIRECTORS OF THE CORPORATION OR THE BOARD OF TRUSTEES OF THE SOCIETY SHALL NOMINATE AND ELECT DIRECTORS. IN THE EVENT OF A CONFLICT BETWEEN THE TWO, THE DECISION OF THE SOCIETY BOARD OF TRUSTEES SHALL PREVAIL. AT LEAST TWO OF THE DIRECTORS, IN ADDITION TO THE PRESIDENT AND SECRETARY/TREASURER, MUST BE MEMBERS OF THE BOARD OF TRUSTEES OF THE SOCIETY, AND THESE DIRECTORS SHALL SERVE IN THE ROLE OF LIAISON TO THE SOCIETY. THE BOARD OF TRUSTEES OF THE SOCIETY MUST APPOINT OR DIRECTLY ELECT THE MAJORITY OF THE DIRECTORS. SECTION 3.7 OF THE FOUNDATION'S BYLAWS WAS DELETED AND REPLACED WITH NEW SECTION 3.7 AS FOLLOWS: 3.7 VACANCIES. THE BOARD OF DIRECTORS OF THE CORPORATION OR THE BOARD OF TRUSTEES OF THE SOCIETY SHALL NOMINATE AND ELECT DIRECTORS TO FILL VACANCIES ON THE BOARD OF DIRECTORS. IN THE EVENT OF A CONFLICT BETWEEN THE TWO, THE DECISION OF THE SOCIETY BOARD OF TRUSTEES SHALL PREVAIL. IN ACCORDANCE WITH SECTION 3.4, ABOVE, THE BOARD OF TRUSTEES OF THE SOCIETY MUST APPOINT OR DIRECTLY ELECT THE MAJORITY OF THE DIRECTORS.
