28 Project H.E.R.: This program continued to provide free health services (Help, Enlightenment, and Resources) in Benton, Linn and Lincoln counties of Oregon. The Navigator program provides awareness, education and support for patients from the time of cancer diagnosis through survivorship, with the Navigator team, which consists of a nurse navigator, outreach coordinator, and cancer survivors who mentor patients free of charge with the guidance of the nurse navigator. The Project H.E.R. navigator provided support for 120 cancer patients in 2019, and there were 20 active mentors who mentored 18 patients during the year. The Cook for Cancer program served 1,728 meals for 156 families of patients who were undergoing chemotherapy treatments of all types of cancer diagnoses, oncology and hematology. Project H.E.R. sponsored several support groups: Breast Cancer Support Group (12 attendees monthly), GYN Cancer Support Group (11 attendees monthly), and Blood Cancer Support Group (9 attendees monthly). Project H.E.R. personnel also participated in outreach events to increase awareness of cancer prevention and Project H.E.R. support, including sponsorship and tabling at the Soroptimist International Walk for the Cause event, and providing support at numerous Dam Cancer (Pink Out) fundraising athletic events held at the local university and high schools (which included the participation of 32 cancer survivors at various events). In addition to \$26,850 of cash expenditures paid for programming and outreach (which includes \$18,765 paid for a leased employee and \$700 for grants), \$69,245 of donated meals, services and facilities were received in 2019 for Project H.E.R. programs.
