Advertising income is subject to taxation under Section 512 of the Code and resulted in an unrelated business income tax of \$157 for the year ended December 31, 2019. The Federation incurred \$60,251 in unrelated business income tax on employer-provided qualified transportation fringe benefits under Section 274(a)(4) of the Code for the year ended December 31, 2018. During 2019, the unrelated business income tax on employer-provided qualified transportation fringe benefits was repealed retroactively. The Federation will proceed with amending returns as necessary during 2020 seeking refunds of tax paid as a result of the original 2018 tax filings. There was no associated unrelated business income tax benefit for the year ended December 31, 2017. The Federation does not have any significant uncertain tax positions for the years ended December 31, 2019 and 2018. On December 22, 2017, the President signed into law H.R. 1, originally known as the Tax Cuts and Jobs Act. The new law includes several provisions that result in substantial changes to the tax treatment of tax-exempt organizations and their donors. The Federation has reviewed these provisions and the potential impact and concluded the enactment of H.R. 1 will not have a material effect on the operations of the organization.
