Valuescience - taught "Valuescience: Shedding Illusion to Live Better" to 400 people in seminars and meetings at Magic, Stanford, and other local venues including a Stanford Earth Sciences class and a panel at Ford Labs in Celebration of International Women's Day; published a poster that describes Silicon Valley Barcode of Life, one of several dozen initiatives world-wide to track changes in biodiversity using DNA sequencing of specific small genome regions, and to teach people about the importance of biodiversity and motivate them to act to protect it; presented Silicon Valley Barcode of Life at the Apricot Stem Fair where we taught 500 visitors about DNA barcoding arthropods, about the important role arthropods play in ecosystems, and about their rapid decline; collected thirty arthropod samples at Jasper Ridge Biological Preserve, successfully extracted DNA and sequenced nine, and uploaded to the GenBank and BOLD databases two novel ones; published a blog about Silicon Valley Barcode of Life on the Stanford Jasper Ridge Biological Preserve website.
Residential Education - guided thirty-eight residents from sixteen countries and fourteen states within the United States of America in creating valuescience-based service-learning community.
