WORKING TO EXPAND ANIMAL LAW INTO THE CURRICULUM OF EVERY LAW SCHOOL IN THE COUNTRY, THE ANIMAL LAW PROGRAM COLLABORATES WITH STUDENTS, FACULTY, AND SCHOOL ADMINISTRATIONS TO FACILITATE THE DEVELOPMENT OF ANIMAL LAW COURSES AND ASSISTS STUDENTS IN FORMING ANIMAL LEGAL DEFENSE FUND STUDENT CHAPTERS.
