This unique program is intended to drive students toward Science/Technology/Engineering/Math (STEM) education and careers and to give them hands on, project-based learning experience in multiple formats - in the classroom, through independent study, or via science clubs and other after-school activities. At each Planetary Congress, ASE members dedicate a full day for outreach with the local and national communities in the country where the Congress is being hosted. The astronauts and cosmonauts reach thousands of students, teachers, parents, and members of the general public to inspire and promote education in science, technology, engineering and mathematics. ASE-USA member astronauts also engage with students and teachers throughout the year in the USA with school and university visits and lectures, as well as via partnerships with other educational organizations.
