Global to Local Educational Programs. Through books, videos, lectures, reports, conferences, classes, interviews and web-based materials, we inform the public of the many costs of globalization, and the systemic benefits of economic localization. In 2019 we published a new book, Local is Our Future; curated and ran an online film series on The Farms of the Future; organized a campaign on the theme of "insane trade", which included a short film and accompanying factsheet; a organized several conferences and similar events, including Big Picture Activism, in Byron Bay, Australia, and Happiness in a Time of Crisis, in Dorset, UK. Local Futures staff also spoke at numerous other events, including the Newkind Festival and the Sustainable Living Festival (Australia); the Brussels Economic Forum (sponsored by the European Commission); Despierta, el planeta te necesita (Spain), Medicine Festival (UK); Defend the Sacred (Portugal); This is Not a Design (Netherlands); and the Seoul International Appropriate Technology Festival (South Korea). We also continued our ongoing blog series on issues related to the global-to-local shift, our Planet Local series highlighting grass-roots localization initiatives around the world, a number of webinars and podcasts featuring key thinkers and activists from the localization movement.

4b (Code:) (Expenses \$ 71,311 including grants of \$) (Revenue \$)
Economics of Happiness programs. In 2019 we organized and ran four international Economics of Happiness conferences, in Leh, Ladakh (India), Bangalore (India), Jeonju (South Korea), and Yokahama (Japan). At each of these conferences, both international and local presenters spoke about the problems with globalization, the benefits of localization, and strategies and initiatives that can help propel and shift from global to local.

4c (Code:) (Expenses \$ 29,211 including grants of \$) (Revenue \$)
Ladakh Project. In Ladakh in 2019, we teamed up with local NGO Flowering Dharma to run a "Mindful Futures", a four-day residential workshop for Ladakhi youth. We co-sponsored the Little Tibet Film Festival, at which three of our films, Ancient Futures, The Economics of Happiness, and Mindful Travel in Ladakh, were all screened. We organized our annual Help with the Harvest event, in which a core group of volunteers travel to villages to live with and help local families at harvest time. We also screened our films, led discussions, and conducted workshops for the Naropa Fellowship, a 9-month program in social entrepreneurship for youth from across the Himalayan region. And we co-published a new book, Dhontang: Food in Ladakh, with the Central Institute of Buddhist Studies. In addition, we continued our annual summer programs in tourist education, which includes screening our films at the Women's Alliance of Ladakh Center, and disseminating our Mindful Travel pamphlets and factsheets to the many thousands of tourists who visit Ladakh.

There are now more than 160 members of the IAL, representing 65 countries. We have begun soliciting short video statements from IAL members describing, in personal terms, what "local" means to them. These will be posted on our website. We also updated and improved the listserv that enables IAL members to engage in dialogue with one another about best practices, strategies and experiences. And we continued posting our Planet Local entries, describing on-the-ground localization initiatives underway across the world.
