We conduct weekly support groups and have drop-ins hours 4 days/week. Activities include workshops, life-skills activities, leadership and professional development, mentoring, educational programming, fieldtrips, counseling, and more. About 360 youth attended drop-ins and support groups in 2019.

4b (Code) (Expenses \$ 39,874 including grants of \$ 922) (Revenue \$ 0)

Youth gain skills and experience through staff positions. Fellowships, internships, and other opportunities. They participate in leadership trainings. They develop and implement programs, trainings, workshops and other events at Stonewall Youth, schools, organizations, and other community venues. They are active in all areas of work in the organization, including program development and implementation, operations and organizational development. They do outreach and education at community events. 18 youth were in leadership positions in 2018. Their efforts benefitted at least 350 other youth and other community members.

4c (Code) (Expenses \$ 18,286 including grants of \$ 0) (Revenue \$ 26,223)

Along with regular weekly events for youth such as support groups and drop-ins, SY has at least three other events and activities each month. Some of these are specifically for youth, such as art or leadership workshops, open mics with youth performers, or educational activities. Others are for the whole community, such as open houses, potlucks, and workshops. Youth work with adult staff to organize and conduct these events. When possible, we also let community members and organizations use our space for events, art studios, and workspace. We charge a sliding scale fee for these activities. All activities further our mission. About 350 people attended events in 2019.
