

Each week bright red bags filled with award winning books rotate into children's homes, on average exposing each child to more than 100 books per rotation cycle. Raising A Reader pairs this rotation with parent training and connections to the local library to continue the literacy habits they have developed. Raising A Reader partners with a wide range of service agencies and can be adapted with fidelity to meet the needs of diverse families and communities. More than thirty independent studies confirm Raising A Reader's capacity to improve family engagement and literacy.
