CalMedForce- CalMedForce is the Graduate Medical Education (GME) Grant Program supported through Proposition 56 which allocates approximately \$40 million to primary care and emergency medicine GME programs in California. The University of California is the designated recipient of the Proposition 56 funding and has contracted with PHC to administer this GME Grant Program. CalMedForce has successfully completed two cycles and is in the process of finalizing a third cycle. In CalMedForce's first grant cycle, approximately 150 primary care and emergency medicine residents were supported through this grant program. In CalMedForce's first two cycles for FY 2018-2019 and FY 2019-20, approximately 350 primary care and emergency medicine residents were supported through this grant program. CalMedForce is committed to growing a diverse physician workforce by supporting, incentivizing, and expanding graduate medical education in California. Its goal is to grow and strengthen the physician pipeline to meet the demands of California's growing patient population with a focus on medically underserved areas and populations.

4b (Code:) (Expenses \$ 862,770 including grants of \$) (Revenue \$ 1,878,778)

CalHealthCares administers loan repayment on educational debt for California physicians and dentists who provide care to Medi-Cal patients, which represent one-third of Californians and half of the state's children. Eligible physicians can apply for up to \$300,000 in loan repayment in exchange for a five year service obligation. Eligible dentists can apply for a loan repayment up to \$300,000 in exchange for a five-year service obligation or a Practice Support Grant up to \$300,000 in exchange for a ten-year service obligation. CalHealthCares commits voter-approved, state tobacco tax revenues from Proposition 56 (2016) to support and incentivize physicians and dentists to increase participation in the Medi-Cal program. In April 2019, the California Department of Health Care Services (DHCS) launched CalHealthCares, and DHCS has contracted with PHC to administer the statewide program. In CalHealthCares first two annual cycles for FY 2018-19 and FY 2019-20, CalHealthCares awarded approximately \$131.7 million to 571 physicians and dentists providing care to Medi-Cal patients.

Network of Ethnic Physician Organizations (NEPO): NEPO brings together more than 50 ethnic physician organizations from across California to create an empowered, unified voice of ethnic physicians and their organizations to promote diversity, access, and quality, in healthcare. NEPO is designed to identify strategies for building the capacity of Ethnic Physician Organizations, address health disparities and the social determinants of health, improve workforce diversity, engage in leadership development and to encourage physicians and other providers to be community advocates. NEPO hosts an annual Summit which brings together nationally recognized policy leaders, elected officials and physician leaders. This successful Summit draws over 150 physicians, other providers, and policy experts to learn best practices, share information, and network.

Schedule D, Part V, Line 4 - Medical Student Fund - In 1983, a donor established the Medical Student Foundation with PHC. Principal contributions of \$110,811 are to remain intact as a permanently restricted endowment and only the amounts earned as interest income may be expended by PHC for medical student grants. PHC Endowment - This general endowment is comprised of several different endowment contributions made to PHC. The Audio Digest Foundation established the endowment by contributing \$200,500 to PHC in 1989. In 2019, funds originally contributed in 1989 by the leadership of the Audio Digest Foundation, were released from restriction. The release provision was made in writing by the last President and CEO of the Audio Digest Foundation before its dissolution. During 2004, PHC encouraged physicians to donate settlement checks to which they were entitled from a lawsuit brought against CIGNA. The solicitation indicated that all funds donated would become part of the PHC Endowment Fund. Contributions totaled \$245,784. The principal of this endowment must remain intact and only the investment earnings may be expended by PHC. During 2009, PHC received \$12,061 of other contributions with permanent restrictions. From 2014-2017 PHC received a \$10,000 contribution from Blue Shield to be held as an endowment with permanent restrictions. In addition, PHC Board of Directors established the PHC board designated endowment to be used at its discretion. In addition, PHC has various smaller funds that are temporarily restricted by their donor's for specific uses that align with the mission of the organization.

Schedule D, Part X, Line 2 - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires PHC to report information regarding its exposure to various tax positions taken by PHC. PHC has determined whether any tax positions have met the recognition threshold and have measured the exposure to those tax positions. Management believes that PHC has adequately addressed all relevant tax positions and that there are no unrecorded tax liabilities. Federal and state tax authorities generally have the right to examine and audit the previous three years of tax returns filed. Any interest or penalties assessed to the Foundation are recorded in operating expenses. No interest or penalties from federal or state tax authorities were recorded in the accompanying financial statements. With some exceptions, the Association is no longer subject to U.S. Federal and state income tax examinations by tax authorities for years prior to 2014.

Eligible physicians can apply for up to \$300,000 in loan repayment in exchange for a five-year service obligation. Eligible dentists can apply for a loan repayment up to \$300,000 in exchange for a five-year service obligation or a Practice Support Grant up to \$300,000 in exchange for a ten-year service obligation. CalHealthCares commits voter-approved, state tobacco tax revenues from Proposition 56 (2016) to support and incentivize physicians and dentists to increase participation in the Medi-Cal program. In April 2019, the California Department of Health Care Services (DHCS) launched CalHealthCares, and DHCS has contracted with PHC to administer the statewide program.

Form 990, Part VI, Section A, Line 2 - Dustin Corcoran, Officer, and Lance Lewis, Chief Financial Officer, have a family relationship.

Form 990, Part VI, Section A, Line 6 - The organization has shared members with the California Medical Association.

Form 990, Part VI, Section A, Line 7a - Nominees for the PHC's Board of Directors are identified by members of the Board (as general directors or designated directors). The Executive Committee of the Board vets nominees and issues recommendations which are then approved or rejected by the Board. If approved, a written recommendation is then made to the CMA Board of Trustees, which makes a final approval or rejection of the nominee.

Form 990, Part VI, Section B, Line 11b - Form 990 is prepared by California Medical Association's accounting department with details and review provided by PHC staff and management. All questions and comments are resolved prior to filing.

Form 990, Part VI, Section B, Line 12c - The Conflict of Interest policy is affirmed annually, in writing, by each officer, director and key employee. Each person is required to publicly disclose any potential conflicts of interest during consideration of any item of business to the PHC Board. Newly elected officers, directors, or key employees are provided additional instruction on conflicts of interest. Employees are required to disclose potential conflicts of interest in accordance with the personnel policies stated in the employee handbook. The annual affirmation is monitored by PHC's President and by the CEO.
