Santa Ynez Valley Cottage Hospital is a 11-bed acute-care hospital located in the rural area known as the Santa Ynez Valley. In 2019, the Hospital had 523 patient days, served 23,385 outpatients including emergency services to 9,679 patients. The Hospital provided essential emergency treatment, inpatient acute care, outpatient surgical services, imaging diagnostic services, infusion services and cardiac rehabilitation services to the residents of the Santa Ynez Valley, including the communities of Solvang, Buellton, Santa Ynez, Los Olivos, and Ballard. Santa Ynez Valley Cottage Hospital provides emergency services to anyone seeking care, regardless of their ability to pay. The hospital is diligent in ensuring that all patients have adequate access to care. All patients who do not present with insurance are automatically screened for eligibility in government health programs and are assisted in applying for financial assistance if the patient does not qualify for any other assistance. In order to ensure that the Community has access to physician specialists, the Santa Ynez Cottage Valley Hospital also rents medical office space on a per clinic basis. Santa Ynez Valley Cottage Hospital provides critical funding for community health, and external grants, while also realizing shortfalls Medi-Cal and indigent care. In addition, the hospital provides grants to support nursing education, provides low cost exercise program for seniors, has supported health fairs, and the provision of flu shots to the community. In 2019 the hospital spent over \$1.6 million on these programs.

The implementation strategy to address the priority needs includes Santa Ynez Valley Cottage Hospital's grants, its hospital programs and health fairs. In general, an Officer who had disclosed a potential conflict should be excused from the decision making portion of the discussion and is prohibited from voting on a matter involving a potential conflict of interest. If the Board has reasonable cause to believe that a Director or Officer failed to disclose a material financial interest or other potential material conflict of interest, the Board Chair shall inform the member of the basis for the belief and afford the member an opportunity to explain the alleged failure to disclose. After hearing the Director or Officer response and conducting any further necessary investigation, the Board determines if the Director or Officer failed to disclose a material financial or other potential material conflict of interest. The Board Chair shall take appropriate corrective action. Committee Chairs who address conflict of interest situations with a Board Committee member are responsible for reporting such situations to the Board Chair. Key employees are treated as other employees of Cottage Health and sign an annual conflict of interest form. These forms are reviewed by Compliance and any issues are brought to the Chief Compliance Officer.</p>
