Services: The UFW Foundation is the largest Department of Justice (DOJ) recognized immigration legal services provider in rural California. As the only DOJ recognized non-profit with close proximity to the Mesa Verde Detention Center in Bakersfield, the organization continued to grow its removal (deportation) defense program in 2019, opening 17 cases, including 30 cases from Immigration Legal Defense, a nonprofit fiscally sponsored by the UFW Foundation. In 2019, the UFW Foundation directly opened 7,121 new immigration cases. Indirectly, 715 new cases were opened by funded partner agencies and 758 from Immigration Legal Defense. Additionally, community members were provided assistance with tax preparation, eligibility screening and enrollment in safety net programs.

Form 990, Part III, Line 4b:

PolicyFederalIn 2019, the UFW Foundation focused on several federal policy campaigns. In January 2019, the Agricultural Worker Program Act of 2019 (Blue Card bill) was introduced. This legislation, sponsored by the UFW Foundation, was introduced on Jan. 17, 2019 by U.S. Representative Zoe Lofgren (D-Calif.) and Sen. Dianne Feinstein (D-CA). This bill would provide legal status with a path to citizenship for farm workers. Similarly, the UFW Foundation worked in bipartisan fashion, alongside the United Farm Workers of America, to negotiate, introduce and pass the Farm Workforce Modernization Act (H.R.5038). Three farm worker delegations went to Washington DC to speak with Congressional members about the need for legal status. As such, this groundbreaking bill passed the House of Representatives on December 11, 2019 with overwhelming support (260 165), including 34 Republican votes. The bill was received in the Senate on December 12, 2019. This is the first time in decades that the full House, under either party, has enacted an agricultural immigration bill. Additionally, the Fairness for Farm Workers Act by U.S. Sen. Kamala Harris (D-Calif.) and U.S. Rep. Ral M. Grijalva (D-Ariz.) was introduced to end the exclusion of farm workers from overtime pay federally 81 years after nearly all other U.S. workers secured overtime. The UFW Foundation continues to work on passage of these three important bills in 2020.

StateOn February 21 2019, California State Senator Maria Elena Durazo introduced Senate Bill 458, the Protect Children from Brain-Damaging Chlorpyrifos Act of 2019 in the California legislature. UFW Foundation joined our sister organization, the United Farm Workers, and Earthjustice in sponsoring this important legislation. This bill would prohibit the use of pesticide products that contain the brain-damaging ingredient Chlorpyrifos. The UFW Foundation mobilized farm workers who were impacted by Chlorpyrifos poisoning to speak with legislators in the capitol regarding the impact of this chemical. Although Governor Gavin Newsoms Administration announced the start of a regulatory process to end the use of Chlorpyrifos, the UFW Foundation continues push legislation that truly codifies the ban of Chlorpyrifos.

Form 990, Part III, Line 4c:

Systemic Change (formerly, Civic Participation) Through the Systemic Change program, the UFW Foundation lifts the voices of farm workers as they become spokespeople for their communities by interacting with news media and social media, sharing their stories, and informing policymakers of the needs of farm workers and immigrants throughout the year. The organization also conducted outreach events to educate the community about workplace health and safety, the eligibility requirements for safety net programs, available immigration relief and the rights of immigrants. In 2019, the federal administration proposed changes to the H-2A agricultural guestworker program. These proposed changes would impact farm workers wages and job security. Working alongside partner organizations, such as the United Farm Workers and Farmworker Justice, 82,509 public comments were submitted. Additionally, in-depth farm workers testimonies were also shared with congressional members regarding the impact of these proposed changes. H2A Campaign: 82,509 public comments submitted, including 77 in-depth testimonies from workers sharing how Trumps proposed changes to the H2A program would impact their wages and job security, 3,340 postcards from farm workers and rural community members, and 79,092 digital comments from allies and supporters throughout the United States. A joint organizational comment on behalf of the UFW/UFWF that featured worker testimonies was also submitted, and the Chairs (House) and Ranking Members (Senate) of the Judiciary and Labor Committees submitted letters opposing the H-2A proposal as well.
