Re-Entry Housing: Through eight safe homes, A New Way of Life served 78 women, mothers of 64 minor children. The organization also helped 53 women access educational opportunities, and helped 45 out of 68 women seeking employment get jobs. Twelve (12) women discharged parole/probation and 33 women were able to access permanent housing. Services were provided for less than 1/3 the cost of incarceration. On average, 9 out of 10 women served met benchmarks identified as needed for successful community reentry after incarceration. Ninety-nine percent (99%) of the women served were NOT re-incarcerated.

Replication: We founded Sisterhood Alliance for Freedom and Equality which is a training program that will help organizations around the world replicate our model and thus give a fresh start to more formerly incarcerated women. Our first cohort of 12 replicators met for 2 days of training, panel discussions and tours. Our replicators came from Alabama, Arkansas, Illinois and Washington DC.

Re-Entry Legal Clinic: Through 23 legal clinics and individual representation, A New Way of Life helped 352 clients clean up their records. Ten (10) people secured occupational licenses or government clearance for employment. Attorneys were assisted in this work by trained volunteers who provided 215 volunteer days of service throughout the year.

We supported and helped pass eight bills regarding sentencing reform, community service reform, rights to jury service, accountability for peace officers, criminal history record relief and other issues. We mobilized community members to advocate for criminal justice reform in Sacramento and to pass a county motion to cancel a \$1.7 billion jail construction contract. We worked with L A County officials and community leaders to develop recommended alternatives to incarceration. We trained community members in grassroots organizing. We worked with Let's Get Free LA to produce a report on the harm done by criminal system fines and fees. OTHER PROGRAM SERVICES 5: Women Organizing for Justice and Opportunity (WOJO) & Family Integrity: We encourage formerly incarcerated women to find stability and become community leaders by offering them an annual training program that will get them involved in the movement for social justice and sharpen their leadership skills. WOJO advocates distributed advocacy tools for families and community members and provided trainings to address challenges to reunification for families entangled in the criminal courts and best practices for attorneys working with incarcerated parents. OTHER PROGRAM SERVICES 6: Replication: We founded Sisterhood Alliance for Freedom and Equality which is a training program that will help organizations around the world replicate our model and thus give a fresh start to more formerly incarcerated women. Our first cohort of 12 replicators met for 2 days of training, panel discussions and tours. Our replicators came from Alabama, Arkansas, Illinois and Washington DC. OTHER PROGRAM SERVICES 7: Testimony: We encourage formerly incarcerated women and their children to share their truth, trauma and triumph, helping to heal their own pain while sparking awareness at the same time through storytelling. Their lived experiences are captured through video vignettes, guided storytelling, social media, live events and "living libraries". We created 12 videos of these women and their children telling their stories. OTHER PROGRAM SERVICES 8: Developing Opportunities & Offering Reentry Solutions (DOORS): We provide counseling, court advocacy, child visit coordination and supervision, case planning services, and educational resources for families. Since July when we began offering services at DOORS, we have served 78 individuals, with 30 families receiving active case management services.
