These challenges include access to affordable housing, advocacy, and navigation. OPHS provides homeless outreach, case management, rental assistance, housing navigation assistance, transportation to appointments (i.e. housing, medical, DMV), and referrals to partner agencies. OPHS provides services to the homeless neighbors in Artesia, Bellflower, Cerritos, Compton, Downey, Lynwood, Norwalk, and Paramount. In 2019, KCB housed 83 individuals and prevented homelessness for 65 households.

Today, the program services over 125 commercial and residential properties. In 2019, GSI provided workforce development training, mentoring, life skills development opportunities, and the dignity of earning a paycheck for 12 low-income men in the community. Since its inception, GSI has provided on-the-job-training for over 200 men.

Margaret's House is a hospitality home that provides transitional housing and support services for families with children. This program of Kingdom Causes Bellflower (KCB) provides each family with supportive assistance and a dignified, high-quality short-term living experience in return for adherence to program rules. Margaret's House is a unique and effective model for housing at-risk families and remains a key program for impacting underserved populations in the community.
