CIFOR continues to lead the CGIAR Research Program on Forests, Trees and Agroforestry (FTA) - the world's largest research for development program to enhance the crucial role of forests, agroforestry and tree resources across the landscape and along value chains, towards the overarching objectives of sustainable development, food security and nutrition, and to address climate change. The program provides core collaboration with ICRAF, other CGIAR Research Programs and centers, and partners. CIFOR is engaged in two other CGIAR programs - in the IFPRI led Policies, Institutions, and Markets and the CIAT-led program on Climate Change, Agriculture and Food Security

In 2019, CIFOR advanced critical knowledge on social forestry in Southeast Asia, timber legality in Zambia and the DRC, peatland restoration, biofuel, oil palm and mangroves in Indonesia - as well as ongoing global research on REDD+, tenure security, forest landscape restoration and gender

In 2019, Research Support Units supported CIFOR's research programmes by providing state-of-the-art technical services, library facilities, computer services, systems development, and electronic communications

In 2019, CIFOR scientists based around the world produced a total of 330 publications, of which 83% are open access. The publications include 31 books, 49 briefs, 24 chapters, 24 occasional and working papers, 150 journal articles and 52 others. Our publications were downloaded nearly 1.3 million times, with over 11,000 citations and 375,000 Google book visits
