As described in Form 990 Part I line 1 of our mission, Fudan University Education Development Foundation is exclusively established to raise funds to support academic research, talents cultivation and infrastructure constructions in Fudan University and other educational organizations in China. The majority of the donation is supposed to be granted to Fudan University, China. To make good use of all grants and execute sufficient monitor, our foundation sets up the management procedures as below:

- 1) Application: The candidates are required to file application form and submit it with their proposals.
- 2) Screen & Evaluation: Designated professional staffs are responsible for screening and evaluating applications with proposals, then give recommendations for grant action.
- 3) Review & Approval: The applications are reviewed and approved by different level of officers, special management committees, and directors based on the purpose and the amount of grants.
- 4) Periodically Reporting: The beneficiaries are required to provide regular progress reports on quarterly, half yearly or annually basis.
- 5) Final Assessment: When the grant is completed, foundation checks its compliance and effectiveness through expenditure data, reports, and field investigation if necessary.

Besides, to facilitate the monitoring locally, our largest beneficiary, Fudan University, sets up a Grant Administration Office on campus which is full of experienced professional staffs. The office is responsible to both the foundation and the university's grant management. In other words, our foundation can get sufficient information of all the grants and implement supervision with the assistance of that office.
