Essentially unchanged from the original mission, HMN's and the emerging Hummingbird Conservation Networks' (HCNs) mission is to help hummingbirds survive reproduce, and thrive while engaging human communities to benefit economically, socially, and ecologically from their hummingbird conservation activities. Maintaining hummingbird diversity and abundance throughout the Americas is still a primary focus of the organization.

HMN science based activities are organized in 4 work areas: monitoring, research, restoration, and outreach. Activities in 2019 included conducting and coordinating a trend monitoring program with 21 sites in British Columbia, Montana, Idaho, Utah, Colorado, New Mexico, and Arizona. We also conducted a training workshop in the monitoring techniques used as well as presented our results at meetings. Additionally, we sponsored meeting with research collaborators for completing analyses for existing research papers.

4b (Code:) (Expenses \$ 10,786 including grants of \$ 0) (Revenue \$ 0)
To integrate community conservation into HMN's activities, we are beginning a new program, Hummingbird Conservation Communities and Reserves (HCCRs). During 2019, we worked with communities in Nayarit Mexico, Zacapa Guatemala, and high Andean communities in Peru about joining HCCRs. These communities were chosen because they have an interest in hummingbird conservation and their activities will help us address the major conservation issues facing hummingbirds such as discovering conservation needs of a globally threatened species; restoring habitats to mitigate the adverse effect of loss and fragmentation on hummingbird diversity; improving floral resources to ensure food sovereignty of crops pollinated by hummingbirds; and engaging nurseries and gardens to landscape with native hummingbird-visited plants. The expenditures were associated with developing HCCRs resources as well as outreach to these communities.

To meet programmatic needs as HMN's science expands and community activities develop HCCRs, we are developing resources, services, and opportunities to support the resulting networks of collaborators, partners, service providers, communities, and reserves. Collectively, we will be known as Hummingbird Conservation Networks (HCNs). In preparation for these new programmatic requirements, we identified and reserved venues for partner and program meetings planned for 2020.

In 2019, HMN received a legacy gift from the estate of Richard Crawford, formerly of St. George, Utah. This gift of \$610,000 allows the organization to begin implementing the full vision of HMN and the emerging Hummingbird Conservation Networks (HCNs). As a result of this gift, 2019 is the first year that HMN had to use Form 990. In previous years, HMN's tax reporting was accomplished with Form 990-EZ.

HMN has 5.52% partner share in Borderlands Restoration L3C. This relatively new business has yet to demonstrate profitability.

The amount reported to HMN on BR L3C form 1065 represents the value of the HMN's capital account and does not represent payment to HMN. For now, this account allows BR L3C to continue growing the business. When the business is sustainable and profitable,

HMN will receive a portion of the profit as income each year and there are no financial liabilities to this partner share.

The cost of investment in BR L3C was donated to HMN in a previous year.
