There are a total of three trustees, so the foregoing two organizations can control the Trust by majority vote. The third trustee (currently Kenneth F. In 2019, in addition to its support of First United Methodist Church of Winter Park, Florida and the Florida Conference of the United Methodist Church, which are the controlling organizations, the Trust also supported the Candler School of Theology at Emory University, and Duke University, neither of whom are controlling organizations. The Candler School of Theology used its grant from the trust to give scholarship assistance to theology students of its choosing. Duke University used its grant to add to a scholarship fund, entitled the "Bob Bushong Scholarship Fund".
